HB-1007	Looper	Replaces the existing statutory requirements that a private toll road or toll highway company send notice of its intent to construct a toll road, toll highway, or toll road or toll highway project (notice) to the county clerk and recorder of each county that include territory within the 3-mile corridor in which the company intends to construct the road, highway, or project.
HB-1009	Massey	Requires an automobile insurance policy issued, delivered, or renewed on or after January 1, 2009, to contain emergency medical care coverage of at least \$15,000 to cover the costs of all medically necessary and accident-related emergency medical care services provided to a person injured in a motor vehicle accident.
HB-1012	Vaad	Requires the transportation commission to evaluate the state highway system and remove roads from the system if it determines that it is feasible and appropriate to do so.

HB-1057	Sonnenberg	Authorizes the department of transportation to issue permits and adopt rules for the erection, administration and maintenance of tourist-oriented directional signs along freeways and expressways that are not in urbanized areas.
HB-1071	Rose	Changes the background color of the driver's license of a person who has been convicted of certain alcohol-related driving offenses.
HB-1092	Vaad	Allows the formation of a regional transportation authority to be proposed by petition. Specifies information required to be included in and signature requirements for a petition.
HB-1104	Marostica	Creates a new misdemeanor traffic offense, the "aggravated right-of-way offense", to apply when bodily injury or death has been proximately caused by a violation of traffic rights-of-way. Establishes a penalty for committing an aggravated right-of-way offense.

HB-1139	M.May	Requires the Colorado tolling enterprise to evaluate any toll highway offered for sale or for lease and an operating concession by an entity other than the state to determine whether it is in the best interest of the state for the enterprise to purchase or lease the toll highway or a partial interest in the toll highway and to report to the general assembly re- the results of the evaluation.
HB-1146	Swalm	Requires the regional transportation district (RTD) to provide an annual report to the general assembly concerning the additional 0.4% sales tax rate imposed by RTD to finance the FasTracks program.
